The DEPARTMENT OF SCIENCE AND TECHNOLOGY – FOOD AND NUTRITION RESEARCH INSTITUTE (DOST-FNRI), the principal arm of the government in food and nutrition research and development by virtue of Executive Order No. 94 dated July 01, 1947 with office address at the DOST Compound, Gen. Santos Avenue, Bicutan, Taguig City, Metro Manila, represented in this Agreement by its Deputy Director and Officer-in-Charge, Office of the Director, ATTY. LUCIEDEN G. RAZ, hereinafter called the "PROCURING ENTITY"

The **DBP SERVICE CORPORATION**, a private firm duly organized and existing under and by virtue of the laws of the Republic of the Philippines with principal address at 2nd Floor Executive Bldg., Sen. Gil Puyat Avenue cor. Makati Avenue, Makati City, represented by its President, **RAUL LUIS D. MANALIGOD**, by virtue of a Board Resolution No. 54-A dated December 14, 2021, hereinafter referred to as the "**SERVICE PROVIDER**"

WHEREAS, the Procuring Entity requires the services of a qualified staffing service provider for the provision of Human Resources Services for Calendar Year 2024, the "Services";

WHEREAS, for the procurement of said services, a public bidding was conducted pursuant to the provisions of Republic Act No. 9184 and its 2016 revised Implementing Rules and Regulations;

WHEREAS, Service Provider was declared as the Single Calculated and Responsive Bid in accordance with the Republic Act No. 9184, and its 2016 Revised Implementing Rules and Regulations;

WHEREAS, the Procuring Entity Director has approved the BAC Resolution No. 2024-05-08, recommending the Award of Contract to the Service Provider in the amount of Fifty Four Million Nine Hundred Eighty One Thousand Four Hundred Sixty Eight Pesos and 27/100 Only (PhP 54,981,468.27) hereinafter called the "Contract Price";

NOW, THEREFORE, for and in consideration of the foregoing, is entered into by and between the Procuring Entity and the Service Provider, with the following covenants, to wit:
